**SAM ZANGRILLIS:** A defense attorney, mature, assertive, successful and well-dressed.

**KAREN WOOD:** Pleasant, mid-20's, high strung.

**JUSTINE SUITER:** The prison matron, stern.

**JULIE MARSHALL:** The defendant, mid-20's, pretty, intelligent.

**ADRIENNE BANCROFT:** Prosecuting attorney, beautiful, forceful.

**\*TONY (TONI) DELVECCIO:** The bailiff.

**\*JUDGE ROBIN MYERSON:** Mature, commanding.

**\*LEE McGIVER:** The court stenographer.

**DR. JAMES TREVOR:** The coroner, has seen the worst of human nature.

**LT. PHILLIP DEXTER:** A police detective, thorough, precise.

**DIANE HOLGATE:** The murder victim's sister, earthy, bitter.

**MELINDA LAWSON:** The victim's neighbor, an artist, a dreamer.

**BETTY RICE:** A businesswoman.

## **PROP LIST**

### **Preset Props**

Judge's bench: Gavel, papers, pen.

Evidence table: Poker, raincoat.

Stenographer's table: Steno machine or steno's notepad and pencil.

Bulletin board: Crime scene drawing.

### **Personal Props**

Sam: Briefcase with papers, handkerchief.

Adrienne: Briefcase with papers.

Tony: Gun with blanks, holster, Bible, tags and pen.

Phillip: Notebook, key, hair samples, bone sample, 2 documents.

Diane: Handkerchief.

Betty: Magnifying glass.

### **Between Acts**

Add to evidence table: wig in carrying case.

Move hair samples from Adrienne's table to the evidence table.

## ACT I

*(AT RISE: The courtroom is empty except for SAM ZANGRILLIS standing UPS of the defense table. His briefcase is open before him, and he is examining some legal papers. After a beat, KAREN WOOD enters through the double doors, SR. She appears somewhat nervous.)*

KAREN: Mr. Zangrillis?

SAM: Karen...come in. *(KAREN crosses through the gate to SAM. They shake hands.)*

KAREN: Am I too early?

SAM: Not at all. The matron should be bringing Julie in shortly. *(Indicating the US chair at the defense table.)*  
Here, sit down.

KAREN: *(Sitting.)* Thank you.

SAM: *(Crossing SL a couple of steps.)* How are you?

KAREN: I'm a little shaky. I've never seen a murder case being tried before, let alone be involved with one.

SAM: You'll do fine. Julie's counting on you ... you're her only witness.

KAREN: I know. I took a couple of Valium before I came in. They'll help relax me.

SAM: Valium?

KAREN: Yes. I've been under a doctor's care for my nerves for several months now. It's been very stressful ... moving to a new town, finding a job, and a roommate. I was lucky there ... Julie is a dream to live with. She's so kind and understanding. That's why I have to help prove that she's innocent. She could no more have killed Barry Holgate than...than I could! I won't let you down, Mr. Zangrillis ... I swear I won't!

SAM: I trust you.

KAREN: If only I can convince the jury that Julie didn't leave the apartment the night Barry was murdered. Apparently the police didn't believe me ... they arrested her in spite of what I told them.

SAM: (*Crossing SL to the prosecution table.*) They found a witness who swears she saw Julie drive up to Mr. Holgate's cabin that night. It'll be a matter of her word against yours. (*Turning back to KAREN and perching on the edge of the table.*) I believe the rest of the prosecution's case is built on circumstantial evidence. I feel sure we'll be able to prove that this witness, a Melinda Lawson, couldn't possibly identify the figure driving by her place on a dark night as being Julie Marshall ... not without a shadow of a doubt. That's the key word ... doubt. Judge Myerson will instruct the jury that they must not find your roommate guilty unless each and every one of them is totally convinced she took a poker from the fireplace there and bashed in Barry Holgate's skull.

KAREN: When you put it that way, it sounds as if we have a good chance of winning.

SAM: (*Crossing to CS.*) We do. Don't get me wrong ,, it won't be easy. The district attorney, Adrienne Bancroft, is an excellent lawyer. She also has a reputation as being a ruthless adversary. Considering the fact that she and the murder victim had been close friends as well as associates, I have no doubt she'll be out for blood. You mustn't let your guard down with her for an instant.

KAREN: Oh, dear.

SAM: (*Crossing to RC.*) I don't mean to frighten you, but I feel it's necessary to warn you about the Panther Woman - that's what the other lawyers call Adrienne behind her back. She didn't get to be the district attorney by batting her eyelashes, although she is a very attractive woman. Just tell the truth as you know it and you'll be all right.

KAREN: I hope so. I'm not good at confrontations ... I never have been. Even when I know I'm right I get so emotional that I can't stop from bursting into tears and making a fool of myself. I'm doing better, though. Dr. Mendez, my therapist, told me I am. I'm sure he's right. The medication helps a lot.

SAM: I'm glad to hear it. It might be rough, but we'll get through this ordeal just fine.
